Background

- A national action plan to make nursing data sharable, comparable, timely and more relevant to improving health is the foundation of the Nursing Knowledge: Big Data Science Initiative.
- **The Nursing Knowledge: Big Data Science Policy and Advocacy Workgroup** identified the need for a unique nurse identifier to demonstrate the value and contributions of nursing care to improved patient outcomes.



Workgroup Developed Policy Position

- The National Council of State Boards of Nursing (NCSBN) ID should be used by key stakeholders:
 - to serve as a nurse identifier to demonstrate the value of nursing through research.
 - to enhance individual care and health outcomes via more comprehensive documentation in the Electronic Health Record (EHR), Enterprise Resource Planning (ERP) systems and other technologies and systems.



Workgroup Developed Call to Action

A unified voice is essential for advancing advocacy efforts to ensure adoption of a unique nurse identifier for documentation, education, research and training purposes.

1

Develop Policy Position

Identify and document an issue, position or best practice that you want others to adopt or implement.

2

Develop Call to Action

Articulate the value and impact of the position and validate it through publications, research and/or pilots. Include a rationale that will compel others to take the desired action.

3

Outreach to Big Data Policy/Advocacy Workgroup

The Big Data Policy and Advocacy Workgroup will provide guidance on how to develop a policy statement and other resources needed to seek ANI endorsement.

4

Seek ANI Endorsement

Finalize the policy statement and other resources and present to ANI Governing Directors, seeking their endorsement.

5

Resources Posted

Work with ANI leadership to provide resources for the ANI website, educate their members, and equip the ANI Policy Committee for submitting public comments as relevant.

6

Implement Dissemination Plan

Leverage the policy statement and other resources to develop and implement a dissemination plan to advocate for the policy with other relevant organizations, initiatives or projects.
